### 3. Exposure Evaluation:

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S=(PG)/4\pi R^2$$

Where

**S:** power density

**P:** power input to the antenna

**G:** power gain of the antenna in the direction of interest relative to an isotropic radiator.

**R:** distance to the center of radiation of the antenna

### 4. Simultaneous transmission MPE Considerations

According to KDB447498: All transmitters and antennas in the host must be either evaluated for MPE compliance, by measurement or computational modeling, or qualify for the standalone MPE test exclusion in section 7.1. Simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on the calculated/estimated, numerically modeled or measured field strengths or power density, is  $\leq 1.0$ .

This means that:

$$\sum \text{ of MPE ratios } \leq 1.0$$

## 7. Summary simultaneous transmission information

The sample supports two antennas for LORA Antenna and (Bluetooth LE&WLAN) Antenna.

The LORA Antenna and (Bluetooth LE&WLAN) Antenna can transmit simultaneous.

The LORA and (Bluetooth LE&WLAN) with two different Antenna.

According to KDB447498 for Transmitters used in mobile exposure conditions for simultaneous transmission operations;

$\Sigma$  of MPE ratios  $\leq 1.0$

## 8. Summary simultaneous transmission results

LORA ANT. + (Bluetooth LE&2.4G WIFI) ANT. Maximum Simultaneous transmission MPE Ratios is

$0.00849+0.01255=0.02104 \leq 1.0$ .

## 9. Conclusion:

The measurement results comply with the FCC Limit per 47 CFR 2.1091 for the uncontrolled RF Exposure of mobile device.
